### Further Information

1. You must pay an amount of Income Tax and/or Capital Gains Tax at least equal to the tax that Oasis Church Waterloo reclaims on your donations in the appropriate tax year (currently 28p for each £1 you give).
2. You can cancel this declaration at any time by notifying Oasis Church Waterloo.
3. If in the future your circumstances change and you no longer pay tax on your income and/or capital gains equal to the tax that Oasis UK reclaims, you can cancel your declaration.
4. If you pay tax at the higher rate you can claim further tax relief in your Self Assessment tax return.
5. If you are unsure whether your donations qualify for Gift Aid tax relief ask Oasis Church Waterloo or visit the HMRC website.
